- CPTED (Crime Prevention Through Environmental Design) education undertaken by Community Safety and Well-Being officers with businesses downtown
- Following the shooting at 1960 Paris Street, Supt. Brunette, S/Sgt. Ornella and Kaitlyn Dunn hosted a very well-received town hall on safety for the residents
- IPV unit arrested a 40 year old man for historical IPV incidents
- Homicide investigation regarding a fatal shooting on Clemow Avenue

- A random traffic stop led to a seizure of over \$42,000 of drugs
- October 8: Superheroes for Little Heroes event taking place again at the Cancer Centre
- Recruiting video made as part of the OACP Answer the Call campaign
