### **BACKGROUND:**

Section 37 of the *Community Safety and Policing Act* sets out the Board's responsibilities with respect to the provision of adequate and effective police service in the municipality.

More particularly, under Section 37, the Board appoints and accepts resignations of members of the Service.

**SUBJECT: Staffing/Deployment Update**

Each year, the Service develops a Recruitment Plan in accordance with anticipated attrition through resignation and/or retirement. New positions are also identified where required and filled accordingly. Recruiting efforts are ongoing continually to ensure staffing levels are maintained.

During budget deliberations for the 2023 budget, the Board adopted a strategic staffing plan which will increase the Service strength by ten in 2023, ten in 2024, and an additional ten in 2025. Recruiting efforts have been underway to meet the new hiring targets and to be responsive to ongoing attrition through resignation and retirement. As soon as last day at work notices have been given, efforts are made to identify the replacement member.

**CURRENT SITUATION:**

The following tables summarize appointments, resignations, and retirements since the last report to the Board. Unless otherwise stated, the appointments are full-time.

We have successfully met our objective of hiring 30 new Officers over the past three years. Similar to many Police Services, we continue to experience staffing challenges resulting from long-term medical leaves. To mitigate these gaps, we have exceeded our authorized strength. As illustrated in the chart above, 13 sworn members of our 304 actual counts are currently on long-term medical leave of one year or more. Our ongoing priority is to proactively recruit in anticipation of upcoming retirements and to ensure coverage for members on extended leaves of absence.

Dear Mr. Lougheed Jr.:

Thank you for your letter regarding the future transfer of Cecil Facer Youth Centre (CFYC).

The Ministry of Children, Community and Social Services (MCCSS) is working in collaboration with the Ministry of the Solicitor General (SOLGEN) to repurpose the CFYC site for adult offenders, which is necessary to increase capacity in adult correctional facilities in Ontario. This initiative is in line with recommendations made by the Auditor General in 2012 and 2014 reports; it also presents an opportunity for both ministries to leverage existing government and community assets to better support the Greater Sudbury and other Northern communities and keep dangerous criminals off our streets.

For the CFYC transfer, our justice partners, including the Greater Sudbury Police Service, other police services and local courts, will be engaged to assess how this initiative may affect transportation logistics, in-person court attendance, and court release planning.

The ministry remains deeply committed to fulfilling its legislative responsibilities in supporting youth through the Youth Justice Division. Our work is guided by a strong sense of care, accountability, and a focus on achieving positive outcomes for young people. Any transfer planning for youth will be thoughtful and informed by recommendations from the Ontario Ombudsman's report *Lost Opportunities*, as well as insights gained through community engagement.

The planning and preparations for the construction of the SOLGEN-operated adult institution is well underway. CFYC will continue to operate as a youth facility throughout planning and into construction. The timeline for ending admissions to CFYC will be determined as planning progresses.

We understand that effective collaboration with stakeholders is essential to supporting youth programming following the transfer of CFYC. The Youth Justice Division remains committed to engaging with community partners throughout the transition period to share government plans related to the transfer of CFYC to SOLGEN.

The transition period will include a range of engagement approaches to support inclusive participation from all community partners and to address connectivity challenges in some remote First Nations communities. MCCSS has already begun conversations with Indigenous partners, who will continue to be engaged to understand how this initiative may affect Indigenous youth, families, and communities, and to explore strategies to mitigate any impacts. Focused discussions related to CFYC will take place closer to the anticipated transfer date.

**SUBJECT:** 2025 Annual Report on Secondary Activities

---

### **ACTION: For Information**

### **BACKGROUND:**

Under Section 37(h) of the *Community Safety and Policing Act* (CSPA), the Board shall receive an annual report from the Chief of Police on disclosures and decisions made under section 89 of the Act relating to GSPS members engaging in secondary activities/employment.

This legislative requirement is addressed in Board By-Law 2025-009 which establishes governance standards relating to the disclosure of secondary activities pursuant to the *CPSA* and *GSPS Secondary Activities* procedure ADM024. Both documents address the requirements members are to follow with respect to applying for authorization to engage in secondary activities, or to disclose full particulars of an activity they have already undertaken that may place the member in conflict with the *CSPA*.

There are specific requirements regarding off-duty secondary activities for all members including temporary, contract, and term employees. This is to ensure that outside activities do not interfere with the members' duties or detract from public trust and community confidence in the Greater Sudbury Police Service.

In consideration of these guidelines, the Chief may grant approval provided the secondary activity does not contravene the restrictions set out in section 89(1) of the *CSPA* which states:

#### **Restrictions on secondary activities**

89.(1) A member of a police service maintained by the police service board shall not engage in any activity,

- a) that interferes with or influences adversely the performance of his or her duties as a member of a police service, or is likely to do so;

- b) that places him or her in a position of conflict of interest, or is likely to do so;
- c) that would otherwise constitute full-time employment for another person; or
- d) in which he or she has an advantage derived from being a member of a police service.

The Chief may rescind an approval at any time with justifiable cause where:

- a) it is determined the secondary activity has become a contravention of the CSPA;
- b) the secondary activity has adversely affected the performance of the member, or;
- c) the member has failed to comply with the restrictions imposed on the secondary activity, which is in contravention of the CSPA.

The Chief may use discretion on a case-by-case basis to determine if an application is likely to violate Section 89(1) of the Act.

### **CURRENT SITUATION:**

The CSPA requires annual reporting to the Board on secondary activities of members.

Between January 1 – December 31, 2025, the Chief received and reviewed a total of **8** new applications for secondary activities, of which **7** were approved and **1** is pending. **12** renewals were received, all of which were approved. There were no disclosures made.

**SUBJECT:** 2024 – 2025 Continuing Education Tuition Reimbursement - Supplemental

---

### **ACTION: For Information**

### **BACKGROUND:**

In support of the Board's commitment to members of the Service in pursuit of furthering their educational standing, the Board adopted a Continuing Education Tuition Reimbursement policy. This policy is designed to encourage members to further their education relative to their career within the Service. The policy provides for reimbursement to members who have initiated self-study with approval for such reimbursement made in the context of available financial resources. Further, in considering such requests, priority is given to courses which directly benefit the Service.

On an annual basis through the operating budget, an estimated \$5,000 is designated for continuing education purposes to defray professional development expenditures for courses taken by personnel.

In 2001, the Board adopted a Continuing Education policy that provided a number of guidelines for reimbursement including a cap per course of \$500. The costs eligible for reimbursement are for tuition only. Additional expenses such as books, supplies, equipment, lodging, meals, and travel are not considered as part of the subsidy.

In 2010, an amendment was made to the policy limiting the maximum claim entitlement per individual to \$1,000 per year unless otherwise authorized by the Board.

In 2017, a further amendment was made to the policy increasing the maximum reimbursement per course to \$600 and a maximum per individual per year to \$1,200. The Board also designated authority for approval to the Chief of Police.

In 2022, with approval from the Board, the minimum years of service required to qualify for reimbursement was lessened from 5 years to 3 years, working a minimum of 24-hours per week.

**SUBJECT: Supplemental 2024 - 2025 Continuing Education Tuition Reimbursement - Supplemental**

**CURRENT SITUATION:**

In addition to the 6 members previously approved for reimbursement during December 2025, an additional request for reimbursement was received. This submission has also been approved for reimbursement (\$1,200) by the Chief.

### **BACKGROUND:**

Section 49(1) of the *Community Safety and Policing Act* provides for a Police Service Board to contract, sue, and be sued in its own name. As a police service is not a legal entity; it may not enter into contracts in its own name or on behalf of the Board without its authorization.

The Board recognizes the need to ensure accountability in carrying out its statutory and administrative responsibilities. The Board also appreciates the need to advance its work and that of the Greater Sudbury Police Service in an efficient and timely manner.

The Board Chair is the designated signing authority for contracts, agreements, travel claims, vacation approvals for the Chief of Police, legal services, and reserve fund draws.

The Board recognizes the need to delegate signing authority to the Chief of Police or designate to ensure accountability in carrying out the operational responsibilities of the Board for matters necessary for the management of day-to-day operations.

Where delegations of authority have been granted by the Board to the Chief of Police or designate, the delegation includes the authority to execute any related documents in the name of the Board unless the terms of the delegation require the signature of the Board. GSPSB Policy – 030 establishes clear direction on the delegation of signing authority for the Chief of Police.

**SUBJECT: Delegation of Signing Authority****CURRENT SITUATION:**

Pursuant to the authority delegated to the Chief or Designate by the Board, the Chief of Police shall provide a report to the Board regarding all procurement contracts and agreements approved and executed by the Chief or Designate of an operational nature valued at less than \$50,000.

When considering request for funds, the Board takes into account initiatives supporting community-oriented policing that involves a co-operative effort on the part of the Greater Sudbury Police Service and youth in the community, initiatives benefiting children and/or youth and/or their families, initiatives addressing violence prevention or prevention of repetition of violence or the root causes of violence, initiatives that focus on marginalized or underprivileged youth, and sponsorship of educational events.

### **BACKGROUND:**

The City of Greater Sudbury Bylaw #2020-125 establishes and continues Reserves, Reserve Funds, and Trust Funds for the City of Greater Sudbury.

One such reserve fund is the Police Services Board Trust Reserve Fund which is funded from the Greater Sudbury Police Services (GSPS) Board on-line auctions. In addition, monies are recovered through interest earned and monies recovered as a result of seized property. This Reserve Trust Fund is to be used for charitable or other events the Board deems suitable including any purpose that GSPS considers in public interest in accordance with Section 258-259 of the *Community Safety and Policing Act*.

### **CURRENT SITUATION/REQUESTS:**

The Board Trust Reserve Fund is used for any purpose that the Board considers in the public interest in accordance with Sections 258 and 259 of the *Community Safety and Policing Act* and for such charitable events as deemed suitable by the Board without further authorizations by Council.

Requests for funding consideration have been received.

The balance in the Board Trust Reserve Fund on December 31, 2025, was **\$8,373.67**.

**E PLATOON – POLICE REPORTING CENTER (PRC)**

Officers assigned to E Platoon directly contribute to improving efficiencies, service delivery, and alternative resource deployment. In doing so, a high number of incidents are diverted from front-line Patrol members. They perform a critical function for our Service. E Platoon members take low-threshold complaints by telephone and online via online reporting, completing reports, and follow-ups as required.

E Platoon is staffed by 16 members – 13 sworn police officers and 3 Community Safety Personnel (CSPs). Triaged incidents are sent to E Platoon for dispatch and/or further investigation, diverting calls away from front-line Patrol members.

In December, **692** online Rubicon reports were received.

Top reported incidents:

Shoplifting/Retail Theft	99

**PATROL OPERATIONS**

The Patrol Division renewed its focus on the downtown core after the completion of the Support 360 initiative.

On each dayshift Monday through Friday, Patrol members were and continue to be assigned to work downtown. Officers respond to calls for service, engage with community members, challenge open-air drug use, provide service referrals, issue offence notices, and lay charges where applicable.

**41** Focused Patrols were conducted by Patrol members, resulting in the seizures of drugs and drug paraphernalia, amongst service referrals.



**Noteworthy Events:**

**Impaired Driving Arrests – Month of December**

**Situation:** Throughout December, Patrol members targeted impaired driving within the city.

**Results:** Patrol members arrested **28** individuals for impaired driving, laying **50** related charges.

**Homicide**

**Situation:** On Dec 22, 2025, Patrol members attended an address in Lively to check on the wellbeing of an occupant. Callers reported being worried for the safety of the occupant, due to known issues with a family member.

**Response:** Officers arrived on scene and entered the address to check on the victim. The victim was found deceased inside the apartment.

**Result:** Patrol members located and arrested the suspect on scene. The suspect was charged accordingly.

**911 EMERGENCY COMMUNICATIONS CENTER (911-ECC)**

The 911-ECC triaged a total of 6,129 911 calls in the month of December.

The ECC is continuing to prepare for migration to the NG-911 system with testing commencing in February.

**MAJOR CRIME SECTION**

**Intimate Partner Violence (IPV) Unit – Pilot Project Update**

The Intimate Partner Violence (IPV) Unit was launched as a Phase 1 pilot project in 2025 to enhance investigative quality, improve victim engagement, and reduce frontline patrol demand. Early results demonstrate that the unit is operationally effective, delivering measurable efficiencies, and strengthening trauma-informed service delivery.

The pilot operates with a dedicated and specialized team consisting of:

- 4 Constables
- 1 Detective Sergeant (Supervisor)

This staffing model has enabled consistent oversight, investigative continuity, and timely case progression.

**Operational Performance (July – December 2025):**

During the first six months of operation, the IPV Unit achieved the following outcomes:

- Managed and fully investigated 511 IPV calls for service, ensuring accountability and consistency while reducing duplication of effort.
- Conducted 56 IPV-related arrests

By assuming full investigative carriage, the unit has removed investigative workload from frontline patrol, allowing patrol officers to remain available for emergent and priority calls.

- **Estimated patrol hours saved: ~1,696 hours**

This represents a significant redeployment of frontline capacity back into core patrol functions.



**Virtual Choice Reporting (VCR) Initiative:**

To further modernize service delivery and improve victim access, the IPV Unit implemented Virtual Choice Reporting (VCR) in October 2025.

Purpose and Benefits:

- Enhances access for victims unable or unwilling to attend in-person interviews
- Provides a flexible, victim-centered, trauma-informed reporting option
- Reduces logistical barriers while maintaining investigative integrity

Performance Since Launch:

- ***Approximately 30 VCR interviews have been completed.***

Early uptake indicates strong potential for VCR as an effective supplementary investigative tool, particularly for vulnerable or high-stress victims. These early indicators support the continued operation and potential expansion of the IPV Unit beyond the pilot phase.

**Structure Fire Investigation – Notre Dame Avenue**

**Situation:** Around 1:30 p.m. on November 1, 2025, police were contacted by fire services regarding a structure fire on Notre Dame Avenue. The fire caused extensive damage to the building and displaced multiple individuals living in the residential units above the storefront.

**Response:** Officers investigated the cause of the fire, reviewed witness information, and obtained an image of the person observed near the building. As the investigation progressed, officers worked to identify the person of interest and continued to gather evidence linking the individual to the fire.

**Outcome:** Through the ongoing investigation, officers identified a 30-year-old male believed to be responsible. On November 5, 2025, officers arrested and charged this individual with Arson – Disregard for Human Life, Arson – Damage to Property, and Breach of Probation under the Criminal Code of Canada.

**INTEGRATED CRIME SECTION**

**Police Execute CDSA Warrant at 1960 Paris Street Leading to Multiple Arrests and Seizures**

**Situation:** Detectives from the Drug Enforcement Unit (DEU) were conducting an ongoing drug-trafficking investigation in Sudbury that identified an apartment on Paris Street as being associated with the distribution of controlled substances.

**Response:** On November 5, 2025, investigators executed a Controlled Drugs and Substances Act (CDSA) search warrant at the residence with assistance from the Emergency Response Unit (ERU) and the K9 Unit. Two individuals were located inside the apartment and arrested without incident.



**Outcome:** Charges were laid against one adult male from the Greater Toronto Area and one young person from Sudbury. The investigation concluded with the seizure of illegal drugs and proceeds of crime, disrupting drug-trafficking activity within the Sudbury community.

- 24 grams of cocaine seized
- 124 oxycodone pills seized
- Approximately \$15,000 in Canadian currency seized
- Estimated street value of drugs: \$3,100

Charges laid for:

- Possession of Cocaine for the Purpose of Trafficking,
- Possession of Oxycodone for the Purpose of Trafficking, and
- Possession of Property Obtained by Crime over \$5,000

One accused was already before the courts for drug-trafficking charges earlier in 2025

**Breached Release Conditions Lead to Large Drug Seizure**

**Situation:** On November 18<sup>th</sup>, as part of ongoing efforts to monitor high-risk offenders, officers identified a 29-year-old male—previously charged with multiple drug-related and proceeds of crime offences—who was suspected of breaching recent release conditions requiring GPS monitoring and constant supervision by a surety. New information was received indicating the individual had resumed trafficking illicit drugs, including blue fentanyl.

**Response:** Officers undertook targeted surveillance and enforcement action to address the suspected breach and prevent further drug-trafficking activity.

- Officers observed the male leave a residence alone in a taxi
- A traffic stop was conducted on Brady Street, where the male was arrested for breaching his release order
- A search incident to arrest revealed suspected drugs and cash concealed in his clothing

**Outcome:** The enforcement action resulted in the seizure of a significant quantity of illicit drugs and proceeds of crime, reducing the immediate risk to public safety. Officers seized approximately:

- 9 ounces of blue fentanyl
- 1 ounce of cocaine
- 1 ounce of crack cocaine
- Approximately \$3,000 in Canadian currency

Charges related to drug trafficking, possession for the purpose of trafficking, and breaching a release order are pending.



**High-Risk Offender Caught Leaving Home with \$30K in Suspected Drugs**

**Situation:** Around 10:40 p.m. on November 18, 2025, officers were conducting a compliance check on a high-risk offender bound by multiple court-ordered release conditions, including house arrest. During this check, the 29-year-old male was found to be outside of his residence contrary to his conditions.

**Response:** Officers conducted a traffic stop at Brady Street and Grey Street, taking the male into custody without incident. A search incident to arrest resulted in the seizure of:

- approximately 252 grams of suspected Fentanyl,
- 25 grams of suspected Cocaine,
- 21 grams of suspected Crack Cocaine,
- 10 Oxycodone pills, and
- \$2,500 in cash.

The combined estimated street value of the seized drugs is approximately \$30,000.

**Outcome:** The 29-year-old male was charged with Possession of a Schedule I Substance for the Purpose of Trafficking (three counts), Possession of Property Obtained by Crime under \$5,000, and Breach of Release Order. This marks the third time in three months that the individual has been arrested in relation to illicit drug trafficking activity.

**Drug Trafficking Investigation Leads to Arrests and Firearm Seizure**

**Situation:** On November 27, 2025, Detectives were conducting a drug-trafficking investigation in Greater Sudbury. During the investigation, officers conducted a traffic stop on a vehicle on Jean Street. Inside the vehicle were a 37-year-old male from Greater Sudbury, and a 16-year-old youth from the Greater Toronto Area.

**Response:** Officers arrested both individuals. The youth resisted arrest, resulting in a brief struggle before being safely taken into custody. A search of the vehicle resulted in the seizure of:

- approximately 3 grams of cocaine and a digital scale,
- \$5,425 in Canadian currency, and
- a loaded 9mm Glock handgun

The 16-year-old male was charged with multiple offences under the *Youth Criminal Justice Act* (YCJA), the *Controlled Drugs and Substances Act* (CDSA), and the *Criminal Code*, including Breach of Sentence Order, firearms offences, Possession of Property Obtained by Crime, Possession for the Purpose of Trafficking Cocaine, and Resisting a Peace Officer.

The 37-year-old male was charged under the CDSA, the *Criminal Code*, and the *Compulsory Automobile Insurance Act* (CAIA) with offences including firearms-related charges, Possession of Property Obtained by Crime, Possession for the Purpose of Trafficking Cocaine, Operation while Prohibited, and Failing to Surrender Insurance.



**Outcome:** The investigation resulted in the seizure of illicit drugs, cash, and a loaded firearm, contributing to ongoing efforts to target drug- and firearm-related crime in the community.

**Hibernation is on Hold as the B.E.A.R. Unit strikes again**

**Situation:** On December 18, 2025, members of the Break Enter and Robbery (B.E.A.R.) Unit, while conducting proactive patrol, identified a vehicle that had been reported stolen several days earlier. The vehicle was located parked at a residential address.

**Response:** B.E.A.R. Unit members coordinated a safe and effective arrest after the individual came back to the vehicle attempted to evade police by intentionally striking an unmarked police vehicle with the stolen vehicle, creating a risk to officer and public safety. A search conducted incident to arrest resulted in the seizure of a significant quantity of suspected cocaine and a large amount of cash. The stolen vehicle was secured and recovered, and the broader investigation into the original theft remains ongoing.

**Outcome:** The individual, a youth, was charged with multiple offences under the *Criminal Code of Canada* and the *Controlled Drugs and Substances Act*, including Dangerous Operation of a Motor Vehicle, assault-related offences involving police, Possession of Property Obtained by Crime, Possession for the Purpose of Trafficking, and Breach of a Release Order.

**INTEGRATED TRAFFIC SAFETY UNIT (ITSU) – TRAFFIC MANAGEMENT UNIT & SPECIALIZED ENFORCEMENT UNIT**

**Enforcement Activity**

**Provincial Offence Notices (PONs) & Part III Summons**

- December: ITSU issued **188** PONs including **55** Part III summonses.
- Year-to-Date: **1,883** POA charges laid (**2024 YTD: 1,796**)

**Motor Vehicle Collisions (MVCs)**

In December 2025, GSPS recorded 349 total collisions (38 on-scene; 311 self-reported), involving 503 total parties (vehicles reported). The collision data is provided through the GSPS Collision Reporting Centre by Accident Support Services International Ltd.

ITSU entered into 1 fatal MVC investigation and 1 serious personal injury MVC investigation during the reporting period. Remotely Piloted Aircraft System (RPAS) was deployed 2 times in support of collision documentation and evidence capture.

On-scene collision classification for December included 7 non-fatal injury, 25 property-damage-only, and 3 non-reportable collisions.

The collision reporting also captured 6 incidents involving improper licences, 2 incidents involving suspended licences, and 4 breathalyzers administered.

**Impaired Driving – Service-Wide**

In December 2025, 32 drivers were charged (impaired by drugs / over 80), including 24 alcohol-impaired, 5 drug-impaired, 1 alcohol/drug, and 1 refusal. Testing conducted included 26 Approved Screening Device (ASD), 1 Standard Field Sobriety Test (SFST), and 6 Drug Recognition Exam (DRE) tests.

Year-to-Date Context (2025): GSPS recorded 318 impaired-driving incidents, including 189 impaired by alcohol, 113 impaired by drug, and 3 impaired by alcohol and drug.



### **Stunt Driving & High-Risk Driving**

In December 2025, 6 stunt-driving charges were laid. All stunt-driving charges were laid in speed zones under 80 km/h.

### **Initiatives / Focus Areas (December)**

#### **Festive RIDE Campaign – Results and Context**

During the 2025 Festive RIDE campaign, members conducted **2,172** vehicle checks and issued **50** ASD demands and **339** Manday Alcohol Screening (MAS) demands, supported by **8** Breath Tech tests, **6** SFST evaluations, and **4** DRE evaluations. Enforcement outcomes included **11** impaired-driving charges, **8** over 80 charges, and **2** refusals. Administrative roadside measures included **8** three-day suspensions, **4** seven-day suspensions, **2** thirty-day suspensions, and **10** ninety-day suspensions, as well as **3** novice-driver alcohol suspensions. Officers also laid **43** Highway Traffic Act (HTA) offences and **1** cannabis offence as part of the campaign.

For comparison, the 2024 Festive RIDE campaign included **3,243** vehicles checked, **140** ASD tests, **406** MAS tests, **13** Intoxilyzer tests, **8** impaired-driving charges, **7** over 80 charges, **0** refusals, **24** three-day suspensions, **4** novice/young driver suspensions, **40** HTA violations, and **1** cannabis-related charge.

#### **MSV Patrols / Trail Enforcement**

The Specialized Enforcement Unit will be commencing motorized snow vehicle patrols across the area trail system (approximately **1,200 km** of trails), supporting winter-season enforcement, trail safety, permit compliance, and trespassing-related concerns. Following engagement with the Sudbury Trail Plan, Directors requested increased enforcement related to **trail permits** and **trespassing**. All officers have been directed to increase enforcement where trail pass compliance is not met.

#### **Commercial Motor Vehicle (CMV) Blitz (OPP / MTO) Results**

**38** CMV stops, **16** inspections, **5** vehicles placed out of service; **50** CMV charges and **5** non-CMV charges were laid. The CMV blitz reflects ongoing joint enforcement with the OPP and MTO to promote commercial motor vehicle compliance and roadway safety. Targeted inspections and out-of-service actions support risk reduction on key corridors during a period of increased seasonal travel and winter driving conditions.

#### **School Bus Enforcement**

Violations continue to be a concern (1960 Paris area; Lloyd at Mathew). **7** charges were laid for failing to stop for school buses. The Consortium continues to capture video and report via our online reporting system.

#### **EMERGENCY RESPONSE UNIT (ERU)**

#### **Monthly Stats – December 2025**

ERU continued to provide specialized operational support to frontline and investigative units throughout December.



**Operational Activity:**

- Calls for Service: **173**
- K9 Requests: **9**
- Focused Patrols: **2**
- Search Warrants: **2**
- TEMS (Tactical Emergency Medics) Deployments: **2**
- Requests for Assistance from Investigative Units: **2**
- Significant Tactical Incidents: **2**

**Incidents of Interest**

- **Robbery / Severe Assault (Elm St.):** ERU and K9 assisted Uniform Patrol following a robbery at the Kwik Way where the store clerk was severely assaulted and the suspect fled on foot. A track led to a residence containment until a warrant was obtained and ERU could make entry. Multiple persons were taken into custody including the robbery suspect who was arrested.
- **IPV-related Firearms Occurrence:** ERU assisted Uniform Patrol following a 911 hang-up/unknown trouble call where a female could be heard in distress. The investigation was determined to be IPV-related and involved a firearm. ERU contained the residence, negotiators engaged, and a male and female surrendered and were taken into custody without incident.

**K9 UNIT**

K9 support remained an important operational capability through December, supporting ERU and frontline operations through deployments that included a **robbery**, **stolen vehicle**, **mental health** occurrences, **assault**, **disturb the peace**, **police assistance**, and a **motor vehicle collision** response.

In addition to general deployment activity, notable outcomes in December included:

- **Disturb the Peace / Wanted Person:** Following a traffic stop where a wanted male fled, K9 assisted ERU with residence follow-up where the male was located hiding in a bedroom and arrested.
- **Assault / Wanted Persons:** K9 supported ERU entry on a Feeney warrant to arrest two wanted persons. One female attempted to flee and was arrested.
- **Mental Health Act / Life-Safety Track:** K9 assisted Patrol with a suicidal male who fled into a bush area. K9 tracked over multiple ridges and located the male in medical distress. EMS provided treatment and the individual was transported to HSN for a mental health assessment.
- **Robbery / Evidence Recovery and Arrest:** K9 assisted Patrol with a robbery on Eyre Street. A track led to a residence, with clothing and other evidence located during the track. ERU contained the residence while a warrant was obtained, and the male was arrested upon exiting

From the 2025 Polar Plunge earlier this year, we raised over \$47,000 thanks to the generosity and courage of our incredible participants and supporters. 



In December 2020, at just 10 years old, Isabella wore her ribbon skirt to school for Formal Day, only to be told by a staff member that it did not meet the dress code. A formal apology was made by the school division, but Isabella's story sparked a movement to honour Indigenous women by wearing ribbon skirts, allowing them to express pride in their identity and heritage.
