PRESENTATION

Barbara Ridley – Executive Director, Salvation Army Sudbury Cedar Place

The Board invited the Executive Director of Sudbury Cedar Place to give a presentation on the effect the intimate partner violence (IPV) epidemic has on the accessibility of shelter services in Sudbury.

Items of note from her presentation include:

- Cedar Place can house 28 women and children
- Operating at over 100% capacity
- Biggest predictor of homelessness in women is IPV and coercive behaviour with intimate partners
- IPV still has to be considered under the *Family Act* in the court process
- Legislation under way to make it criminal to use coercive control
- The World Health Organization (WHO) labels IPV as a major health concern
- Organizations like Cedar Place are advocating for a standalone law that criminalizes using coercive behaviour on children
- Cedar Place has to turn away 170 women a month
- The average length of stay at Cedar Place has gone from 16 days to over a year in recent years
- Lack of affordable housing causes people to leave the community, homelessness, transient housing/couch surfing, and returns to unsafe situations

The Board asked what would help make accessing assistance easier for those Cedar Place helps. Ms. Ridley noted a central hub for accessible services would make getting assistance easier and notes anecdotal evidence of other cities that centralize social services, legal assistance, financial assistance, etc.

Deputy Chief Hiltz shared that CSWB panel is working to connect services. The steering committee should be up and running in first half of 2026. Member Fortier shared she would be interested in sitting on the committee once up and running.

Chief Cunningham notes the province is trying to increase capacity for adult offenders in light of bail compliance laws. Chief Cunningham notes she will compare recent costs of prisoner transport and update the Board.

The Chief's Report was circulated in advance of the meeting. Chief Cunningham highlighted several activities of the Service throughout December and January for the Board.

Chief Cunningham noted the following:

- The Service's new online reporting software, Rubicon, has been fully rolled out with E Platoon
- The IPV pilot will likely continue on as permanent unit. 511 IPV calls have been taken by this unit, resulting in 56 arrests. The unit has saved Patrol Operations 1700 hours of officer time, allowing for proactive patrols in regular patrol
- Next meeting the Service will bring forward more reporting on VCR software.
- Chief Cunningham noted the recent Ribbon Skirt Day ceremony

- She also noted the upcoming Fire + Ice Game charity hockey game, Law Enforcement Torch Snowmobile Ride, and the Polar Plunge

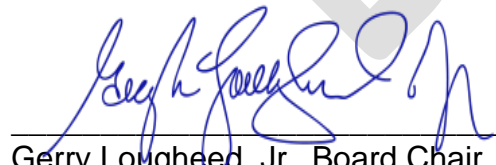
