## **Civil Remedies for Illicit Activities (CRIA) Applications**

The Board was advised that applications for funding were submitted . Project Survivor will increase GSPS' ability to educate our community on the signs and prevalence of human trafficking, reporting avenues, and support services for victims and survivors.

Project TIIPS – Trauma-Informed Indigenous Prevention and Support will provide in-person/virtual culturally sensitive victim support, safety planning and outreach to reduce victimization and violence against Indigenous women and girls, along with ensuring GSPS officers receive Indigenous-centred and trauma-informed training on violence against Indigenous women and girls and the systemic barriers for accessing services among survivors.

## **Report from Chief**

Chief Pedersen reviewed his report as circulated with the Board Agenda highlighting certain activities for the months of December 2020 and early January 2021. Of note are the many Ministry of Solicitor General updates regarding the pandemic and changes to status. Chief Pedersen advised that recognition of new and promoted members were being recognized in a safe way.

Chair Poratto-Mason acknowledged the Chief and all GSPS staff for their work during this difficult and constantly changing situation.

## **Chief's Report – Operational Updates**

Deputy Weber provided background on the reports. Demand for police and 'calls for service' has increased with the COVID-19 pandemic. There has also been an increase in serious partner violence and large drug seizures.

Involved Officers were commended for providing immediate assistance to the unresponsive community member discovered during a Canine track, potentially saving his life.

With the increase in impaired driving incidents, our Traffic Management Unit will be conducting the *#AnywhereAnytimeRIDE* campaign. Officers will be out conducting random R.I.D.E. spot checks during the day and at night, any day of the week to ensure drivers are operating vehicles both lawfully and safely. Road Safety is a Shared Commitment. Please plan ahead for a safe ride home.

**New Business**

Chief Pedersen reported on the 2021 Police Budget presentation to City Finance and Administration Committees which was well received. Chair Poratto-Mason acknowledged the Chief and staff for the excellent presentation; material was well prepared and informative. The Chief fully responded to questions posed by Councillors.

Councillor and Board Member Sizer advised the process of Budget deliberation and the possibility of Police receiving a request to reduce. The full 2021 City Budget is expected to be released in March 2021.
