POLICE SERVICES BOARD



Dr. Rayudu Koka Chair

The Greater Sudbury Police Services Board is comprised of five members: two Provincial appointees, two Municipal Council appointees and one member of the community as appointed by Council.

The Board provides direction and guidance to the Greater Sudbury Police Service, while ensuring that adequate and effective police services are provided in accordance with the needs of the municipality.

The responsibilities of the Board are outlined in Section 31(1) *of the Police Services Act. These responsibilities include:*

- *Appoint the members of the municipal police force;*
- Generally determine, after consultation with the Chief of Police, objectives and priorities with respect to police services in the municipality;
- Establish policies for the effective management of the police force;
- Recruit and appoint the Chief of Police and any Deputy Chief of Police, and annually determine their remuneration and working conditions, taking their submission into account;
- Direct the Chief of Police and monitor his or her performance;
- Establish policies respecting the disclosure by Chiefs of Police of personal information about individuals;
- Receive regular reports from the Chief of Police on disclosures and decisions made under Section 49 (secondary activities);
- Establish guidelines with respect to the legal indemnification of members of the police force for legal costs under Section 50;
- Establish guidelines for dealing with complaints made under Part \mathcal{V} ; and
- Review the Chief of Police's administration of the complaints system under Part V and receive regular reports from the Chief of Police on his or her administration of the complaints system.






IN BRIEF

The City of Greater Sudbury serves as the Regional Capital of Northeastern Ontario. Surrounded by the beauty of the Canadian Shield, the City boasts many natural amenities and several provincial parks are within a short drive. The total land area of the City of Greater Sudbury is 3,354.34 square kilometers. When including the 233 named lakes within its municipal boundaries, the total area of the City is 3,627 square kilometers making it the largest municipality in Ontario based on total area⁴. Municipal amalgamation on January 1, 2001 added 73 lakes to the City with Lake Wanapitei becoming the largest city-contained lake in the world.







2010 HIGHLIGHTS

COMMUNITY MOBILIZATION PROJECT

The Greater Sudbury Police Service successfully applied to the Ministry of Community

Safety and Correction Services under the Proceeds of Crime Front-Line Policing Grant for funding in relation to a Crime Prevention through Community Mobilization Project. The Service initiated this community policing project based on the province's newly developed "Mobilization and Engagement Model of Community Policing". The neighbourhood policing project recognizes that community policing today is very dynamic and requires flexible responses which are dependent upon the particular neighbourhood policed. This Community model dístinguíshes between relatively policina safe neighbourhoods where situational crime prevention measures are appropriate to neighbourhoods where the police are frequently called for assistance and where broader social problems exist. Through the development of the project and by engaging this policing model throughout the City with our community partners, we will collaboratively develop the tactics and strategies required for a safer community.









CHIEF'S YOUTH INITIATIVE FUND

The Chief's Youth Initiative Fund supported numerous youth related activities during 2010. Dedicated to providing financial resources to police driven youth programs in our community, monies are used to offset projects aimed at teen violence, drug-related crimes, bullying, empowering students and providing a variety of opportunities for area youth. In 2010, \$14,450 was given in support of: Strong Kids Campaign, Women of

the Future Conference, Ontario Students Against Impaired Driving, Cops for Kids Summer Camp Program, Donovan Days Bicycles, Young Angler Tournament, Kids and Golfing, Trick or Trek (Halloween event), Sudbury Playground Hockey League Police Cup, Send a Kid to Camp, Aboriginal Secondary School Awards Banquet, Citizen in Action Youth Forum and Graffiti Eradication.







2010 OLYMPIC AND PARALYMPIC WINTER GAMES

Members of the Greater Sudbury Police Service were deployed to British Columbia to assist in policing during the 2010 Winter Games in Vancouver. Under

the direction of the Royal Canadian Mounted Police, 12 officers joined members of the R.C.M.P., the Canadian Forces and other partner agencies for the temporary assignment of providing safety and security in the Games Security Coverage Area which included specific Olympic venues, athletes, coaches and officials.









G8 / G20 SUMMITS

In June 2010, the Government of Canada hosted the G8 Economic Summit in the Town



of Huntsville while the City of Toronto hosted the G20 Summit. In order to assist with security requirements during these two events, the Greater Sudbury Police Service provided the services of its Public Order Unit in the mutual interest of working with the host police services and other policing partners to police these events.

CONSTABLE ERNEST PAUL BRIDGE DEDICATION

In February City Council passed a resolution to request that the Provincial Government dedicate the bridge on Highway 17 at Regional Road 24 in memory of

Constable Ernest Paul. In the early morning hours of May 28, 1955 in the town of Creighton, Constable Paul was seated in the Inco Hotel talking to the night cook. A twenty-two year old deranged male entered. At point blank range, he fired a twenty-two calibre revolver killing Constable Paul. He then shot and wounded two civilians. The male died of a selfinflicted gunshot wound shortly after being taken to the hospital. Constable Paul was married and the



father of four children. The request was processed pursuant to the Ontario Highway Memorials for Fallen Police Officers Act.







FIVE YEAR TREND - CRIMES OF VIOLENCE








FIVE YEAR TREND - CRIMES AGAINST PROPERTY





Youth Crime

Youths are defined as persons aged 12 – 17. Youth crime rates include the number of youths who were formally charged or who were dealt with through extra-judicial (non-



court) measures such as being issued a warning or referral to a community program. Youth crime does not include the number of youth who committed crimes and were not apprehended for their crimes.

In 2010, there were 244 youths directed to the Youth Referral Program with 65% completing their contract.





CRIME PREVENTION

In 2010 Crime Prevention personnel made 64 visits to area daycares, elementary and high schools and spoke to a total of 11,292 students. The most frequently requested workshops were Bullying and Cyberbullying followed by Internet Safety and Streetproofing.

Crime Prevention Officers received 28 requests to attend events and host information kiosks and displays as well as 39 requests by area organizations, associations and businesses for workshops on crime prevention techniques including Identity Theft, Internet Safety and Personal Safety.

Again this year the Service offered the Bullying Mediation Program to all area schools and 28 mediations were conducted with no recidivism for those involved. Officers conducted 21 VIP (Values, Influences and Peers) presentations to 1,201 students in grades 5 and 6. The VIP program is a six-week program that helps the students learn about being responsible citizens, teaching them about the *Youth Criminal Justice Act*, and the dangers of drugs as well as many more topics. The VIP Program is one of the Service's core programs that is designed to help young people reach adulthood safely, become responsible citizens, and to incorporate the values required for success in their future.

The popular Tim Hortons Earn-A-Bike Program saw 35 children receive a new bicycle for their efforts in cleaning up their area neighbourhoods.









ROAD SAFETY AND TRAFFIC MANAGEMENT

The Traffic Management Unit is comprised of six officers and one supervisor who are dedicated to specialized enforcement and preventative activities throughout the City of Greater Sudbury. They perform their duties through the use of marked and unmarked cruisers, motorcycles, snow machines, vessels, and all terrain vehicles. By employing the concepts of high visibility, efficient movement, and deployment with directed enforcement activities, the Traffic Officers have positively contributed to the Service's goal of providing effective traffic safety policing thereby making our roads safer. These officers have been selected because of their experience and interpersonal skills.

Officers assigned to the Traffic Management Unit are responsible for the enforcement of the *Highway Traffic Act*; vehicle inspection initiatives that include private passenger vehicles, taxis and commercial vehicles; parades and special events; V.I.P. and security escorts; R.I.D.E. spot checks; and marine, snowmobile, and ATV patrols.








DRUGS AND ORGANIZED CRIME

Drugs and organized crime are closely linked and collectively impact on a wide array



of other criminal activities. The Service remains committed to participating in strategies with community and law enforcement partners to combat illegal drug use and organized crime.

JOINT FORCE OPERATIONS

On April 22nd, as a result of a lengthy investigation, officers from the Greater Sudbury Police Service, R.C.M.P., and O.P.P. executed a Controlled Drug and Substances Search Warrant at two residences, where a total value of drugs seized was estimated at \$1.5 million. This was the largest seizure for the Police Service in 2010.

Through funding received from the Provincial Anti Violence Intervention Strategy (PAVIS) beginning in December of 2008, our Service immediately began Project "Northbound". This project identified individuals involved in the distribution of crack cocaine both locally and regionally, which included those who are involved in the distribution of cocaine from southern Ontario, and also addressed the possession of trafficking in firearms. In 2010, the Service was successful in targeting and investigating drug offences and organized criminal activities with the following results:



Project Northbound resulted in the following:

- \$1,627,620 drugs seized
- \$67,111 cash seized

<u>**PAVIS Enforcement resulted in the following:**</u>

- 37 gang associates arrested
- \$182,256 drugs seízed
- *\$46,406 cash seized*

Through our PAVIS initiative, enforcement efforts led the Service to identify and address organized criminal organizations from Eastern and Southern Ontario as well as Québec attending our jurisdiction for the purpose of criminal related activities

Project HEAT resulted in the following:

- 44 persons arrested
- 110 charges laid
- \$15,727 drugs seized
- \$6,622 cash seized







CYBER CRIME

The Cyber Crime Unit deals with offences and complaints involving technology, computers and the internet, including active investigations of online child sexual

exploitation and those who commit these crimes against children. The Unit investigators are also members of the Ontario Provincial Strategy to Protect Children from Sexual Abuse and Exploitation on the Internet.

In 2010, the Unit investigated 213 cases, arrested 16 individuals and laid 134 *Criminal Code* charges. As well, the Unit executed 33 search warrants, conducted 84 consent searches and forensically examined 111 cellular devices.

In their prevention capacity the Unit provided 13 community lectures which addressed cyber crime issues to over 1,400 individuals.

PROFESSIONAL POLICING

The *Police Services Act* states that a member of the public may complain about the conduct of an officer or officers, or about policies of or services provided by a police force.

For complaints pertaining to a matter that occurred on or after October 19, 2009 the complaint is referred to the Office of the Independent Police Review Director.

With over 60,000 Calls for Police Service in 2010, the extremely low number of public complaints is an excellent indication of the professionalism of our members.

PROVINCIAL ANTI VIOLENCE INTERVENTION STRATEGY (PAVIS) COMMUNITY GANG FORUM

The Greater Sudbury Police Service is committed to providing adequate and effective



police service to the community including fulfilling one of our core law enforcement functions, the provision of community-based crime prevention initiatives. In this regard the Service held an information session on Youth and Gangs on February 25th, which included two keynote speakers, Ron "Cook" Barrett and Clayton Thomas-Muller. Over 400 people attended the event.

"GANGS ARE HERE" COMMUNITY FORUM

Through PAVIS enforcement initiatives, the Police Service detected coordinated movement of gang-related activity from the Greater Toronto area to Northern Ontario communities and specifically Sudbury. Enforcement initiatives, intelligence and source information identified a significant effort by organized gangs and affiliates to establish a foothold in our community for the sole purpose of distributing cocaine, crack cocaine To supplement ongoing enforcement initiatives, the Greater and other narcotics. Sudbury Police Service held a one-day forum with 200 members from the community including representatives from education, social service agencies, business and other child/youth organizations as well as neighbouring police services including other law enforcement partners, OPP, RCMP and Aboriginal Police Services. The Service recognizes that it is essential that a comprehensive strategy which includes prevention, intervention and suppression be developed to address the presence of gangs and gang-The presentation provided an accelerated level of related criminal activity. understanding of the indicators for gang infiltration, identified the community's vulnerability and invited the attendees to assist in the development of a stategy to address the threat of illegal gang activity and prevent further expansion.

RICK "OZZY" OSBORNE

In 1993, after breaking free from drug addiction Rick began to reform his life and leave behind his gang affiliations, and was one of the few federal inmates in maximum security in Canadian history to earn a University degree while incarcerated. After

leaving prison a decade ago, he dedicated the rest of his life to talking to children and youth about the dangers of gangs, drugs and criminal activity. The Greater Sudbury Police Service ran an initiative from July to October called the "Bike Build". The program, led by Rick, partnered him with at-risk youth while rebuilding a Titan chopper and provided an opportunity for open discussions about youth crime, drug abuse and the threat of the gang



lifestyle. Over 40 youths visited and participated in this project.
