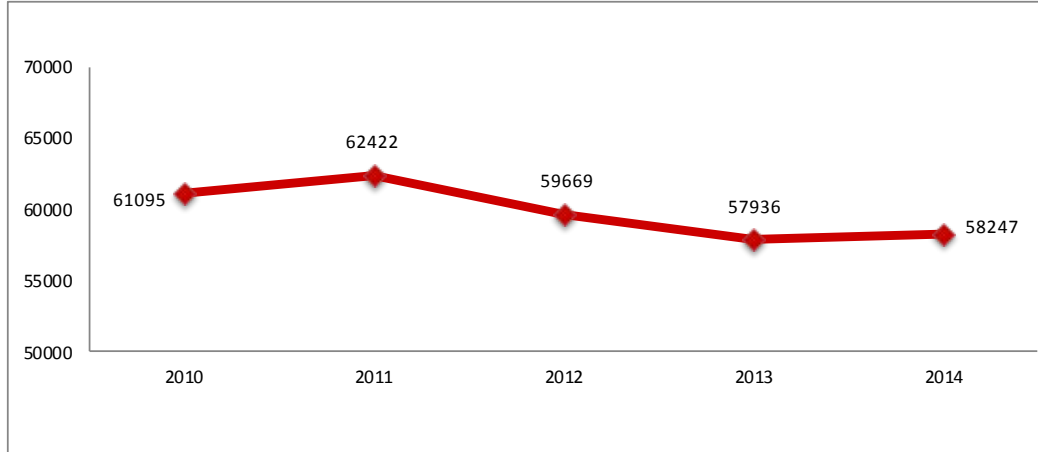


Crime Trends

- Overall crime is down
- Crime statistics do not include incidents that were investigated which resulted in the allegation being unfounded
- Crime represents 15% of what we do locally
- Investment in community safety and well-being
- Collaborative work with partners
 - Rapid MobilizationTable
 - Noah's Space
 - Violent Threat Risk Assessment
- Crime prevention works



Calls For Service - Five Year Trend Analysis

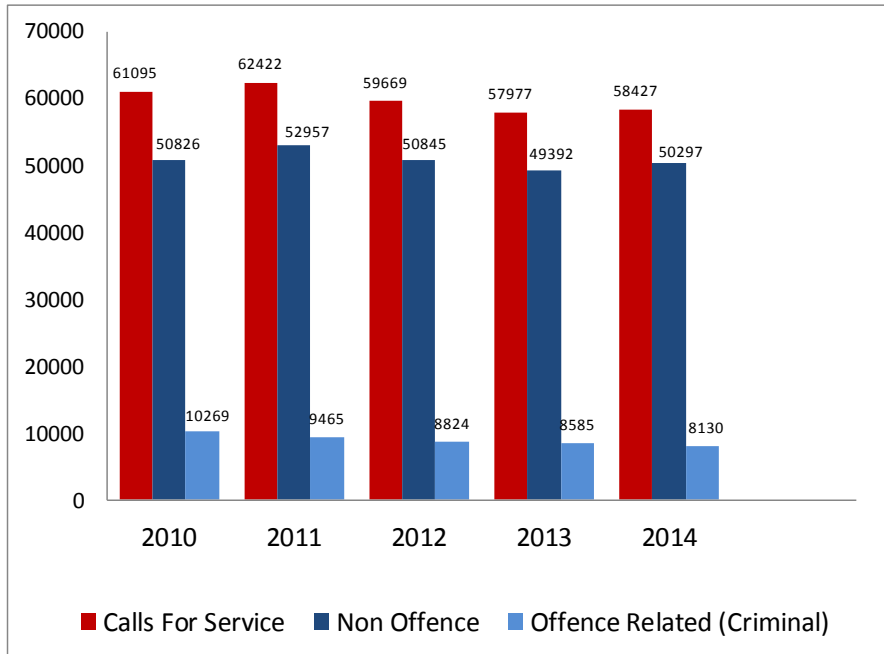


- Calls for Service increased by 0.5% in 2014
- 5 year trend - calls for service down 4.6%
- Problem Based approach to reduce repeat calls in targeted areas
- False Alarm Reduction Program
- Public not reporting minor offences
- Alternate response for non police matters

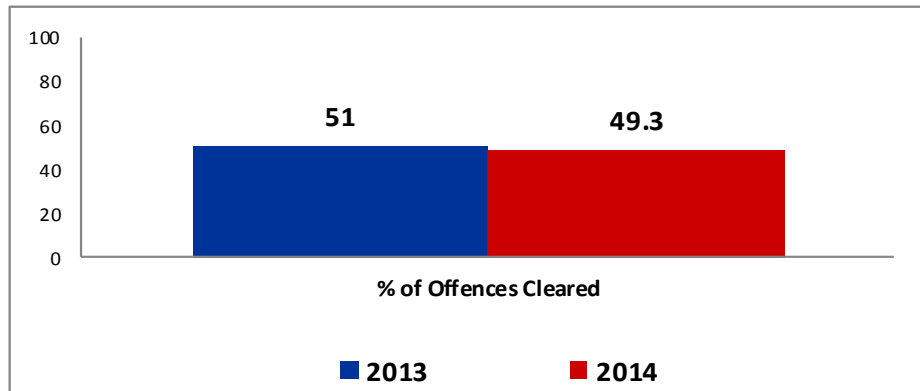
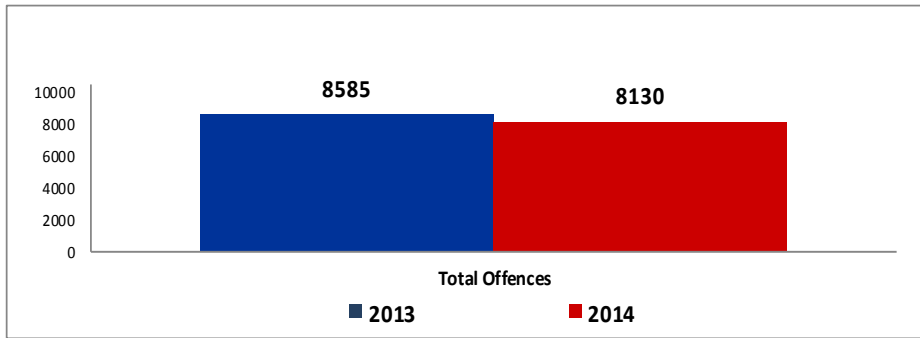
Offence versus Non-Offence



- Consistent 5 year trends in Sudbury
 - 15% of calls are offence related
 - 85% of calls are non offence related
- This trend is consistent across the Province



Total Offences and Clearance Rates

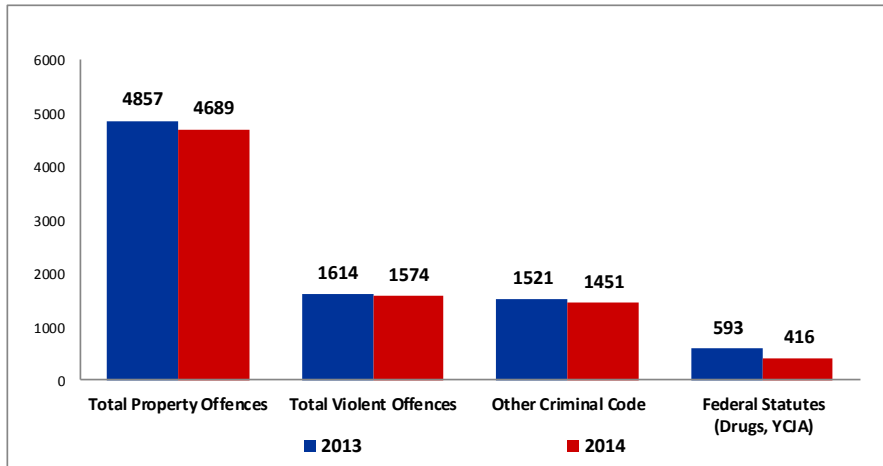


- 5.3% decrease in 2014 total offences
- Consistent with National trends

- 1.7% decrease in 2014 clearances
- Investigative standards and complexities = longer investigations
- Clearances are not always recorded in the same calendar year the offence was reported
- Uniform Crime Reporting Rules place stringent conditions on being able to close an incident as “cleared otherwise”



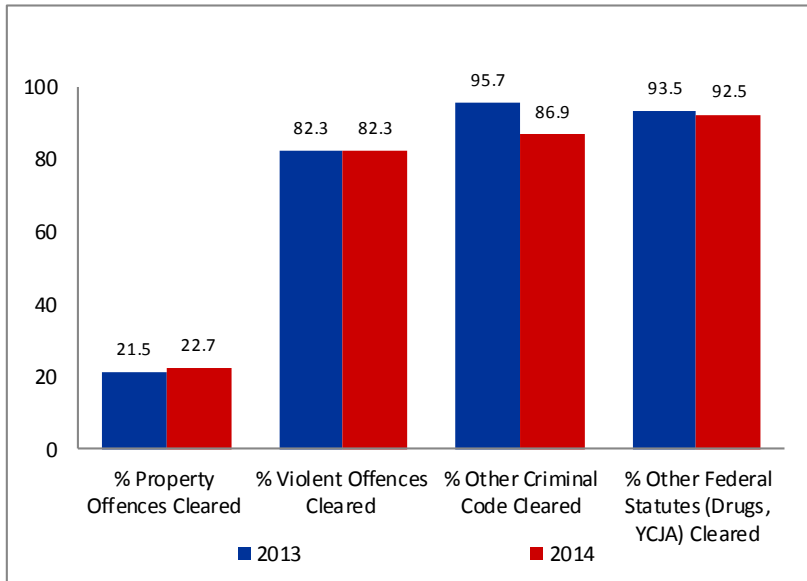
Offences by Major Crime Category



- Property offences are down 3.5%
- Violent offences are down 2.5%
- Other Criminal code offences are down 4.6%
- Federal Statutes are down 29.8%
- Offences that are investigated and deemed to be unfounded are not included
- Crime Statistics are scored based on the Most Serious Violation Rule therefore there could be numerous offences but only the most serious violation is scored



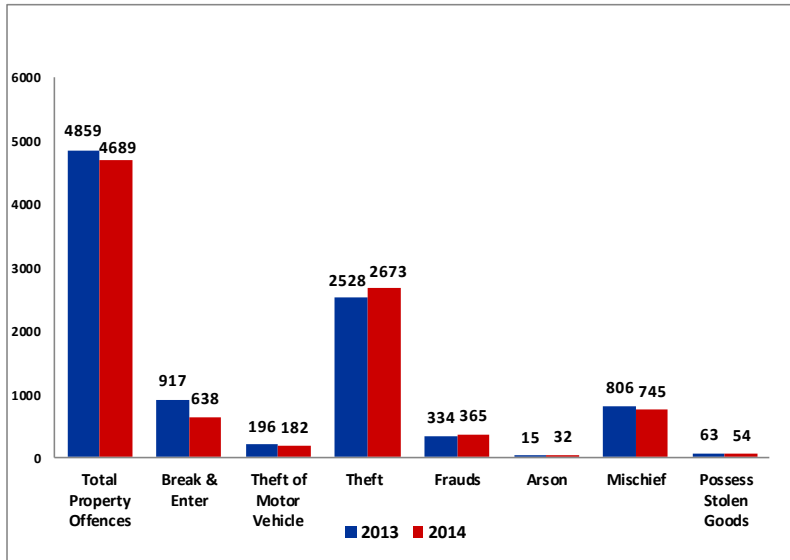
Major Crime Category Clearances



- Investigative standards and complexities = longer investigations
- Clearances are not always recorded in the same calendar year the offence was reported
- Violent Crime clearances higher as in the majority of the incidents, the offender is known to the victim
- Property crimes difficult to solve due to lack of evidence, witnesses, forensics



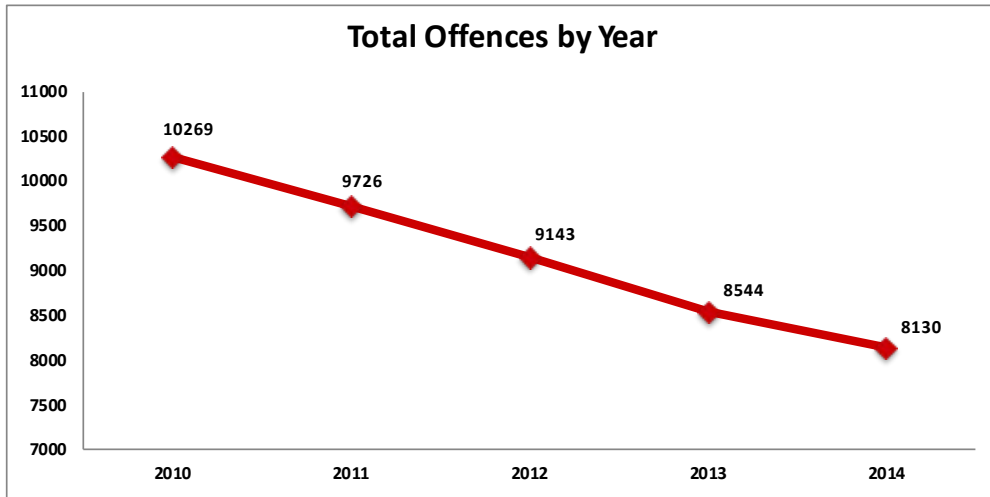
Property Crime Offences



- Break and Enters are down by 30.4%
 - BEAR Unit
 - NOCC Program
 - Focus on prolific offenders
- Thefts are up by 5.7%
- Frauds are up by 14.3%
 - Multi-jurisdiction investigations
 - Economic factors
- Arsons are up by 113.3%
 - Increase in nim bins, porta potties
 - Difficult to investigate
- Shifts in numbers are indicative of the changing nature of crime



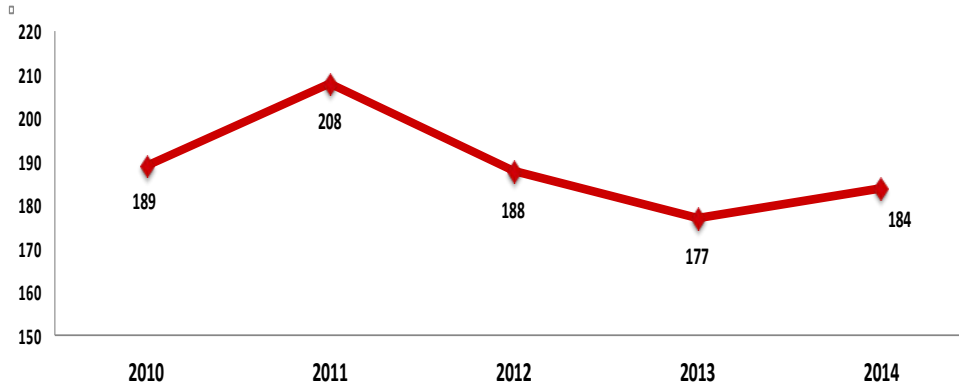
Five Year Trend Analysis



- Consistent with National trends
- Numerous factors can contribute to fluctuations in crime statistics
 - Citizens not reporting crime
 - Enforcement driven crime
 - Social and economic factors
 - Age demographics
 - Crime Prevention Strategies



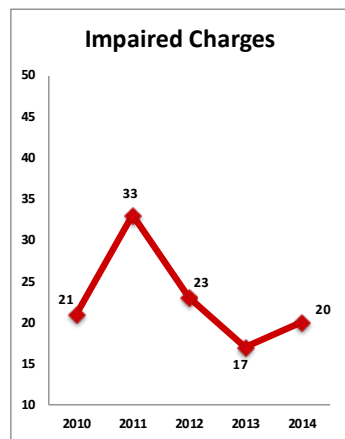
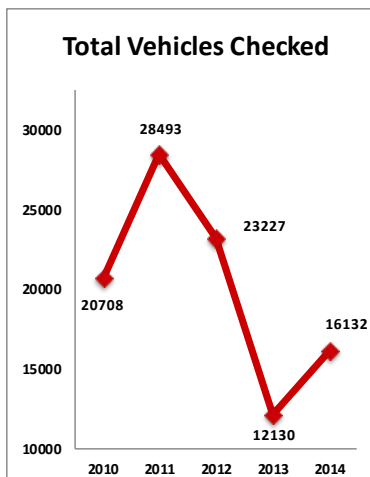
Impaired Driving Offences



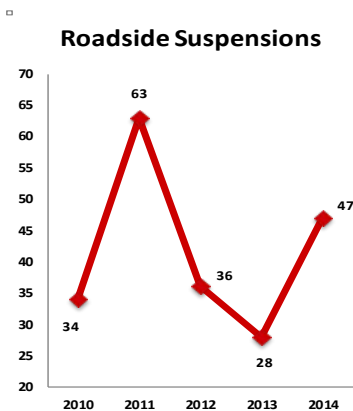
- Increase of 4% in 2014
- Drug Recognition Evaluation Program implemented in May 2013
- Increased Education and Enforcement
- Partnerships to reduce impaired driving
 - MADD
 - Operation Outlook
 - Impact



RIDE Program



- Increase of 33% vehicles checked
- Increase of 6.8% roadside suspensions
- Increase of 17.6% impaired drivers identified in RIDE
- RIDE is a year round program
- Focused on risk during holidays and the festive season
- Increase public awareness, social media and alternate modes of transportation impact on the number of vehicle stops
- RIDE locations in outlying areas produce fewer vehicle stops.
