## **2014 Crime Statistics Presentation**

Chief Pedersen presented the Board with the 2014 Crime Statistics. Overall, crime is down and this trend in reported crime is consistent across Canada. Prevention is key to reducing crime and the Service Delivery Model is followed where the Police:

- ~ champion community safety, security, and wellness
- ~ Initiate and partner to achieve change in community outcomes
- ~ intervene collaboratively to reduce elevated risk situations
- ~ enforce laws and hold offenders accountable

Crime Prevention is an investment in community safety and wellbeing and is clearly having an impact on crime rates. The Service has received positive feedback on the success of the RIDE Program and visibility of officers.

#### **Police Week Overview**

Chief Pedersen spoke on the events planned for Police Week. Since 1970, Police Week has been observed in May to coincide with Peace Offices Memorial Day. The week is recognized during May 11-15, 2015. This year's theme 'Discover Policing' showcases and encourages individuals to discover the many ways policing works to keep communities safe. # **Inspector Updates**

Superintendent Weber advised that the first annual "Our Shared Commitment Awards" banquet will be held May 14, 2015 at the Steelworkers Hall. The Business Plan is almost complete and ready for review and input. Ontario Human Rights Commission training is scheduled for June 1-2, 2015. Board Members are invited to attend. The Ontario Women in Law Enforcement Awards banquet was held recently and the GSPS Inclusion Team won the Team Endeavor award. Several members from the Service were on hand to receive the award as well as long service awards.

Inspector Chapman advised the proposed upcoming changes to WASH (weekend and statutory holiday) Court will increase costs as more persons are being processed. It has been suggested that the Sudbury location become the permanent host for Northern Ontario Courts. The current facilities are neither appropriate nor suitable. As this time, there are no opportunities for cost recovery.

Inspector Zimmerman, CID, reported on Road Safety Week where the Traffic Unit and Uniform Division targeted impaired drivers, improper seat belt use, distracted and aggressive driving. The Volunteer Appreciation Night saw 110 participants awarded. The Auxiliary Unit was acknowledged as well as seven members of the Colour Party. The event was well attended. There is an Urban Renewal Committee which has two members from the Service.

## **Inspector Updates Continued**

A/Inspector Despatie updated the Board on the body located in Junction Creek. Investigation continues with attempts to identify the individuals through requests to the public for assistance.

A/Inspector Somerset, Uniform, advised that all training on CEWs is complete and equipment has been issued. This equipment is a valuable addition for the front-line officer. He also noted that several members from the Community Mobilization Unit have participated in Police Week.
