Community Safety Personnel Presentation

Chief Pedersen made a presentation to the Board on the new Community Safety Personnel (CSP). The CSP program was introduced through the 'Our Shared Commitment to Community Safety and Wellbeing' model of policing. The new CSP roles include Corporate Communications, Crime Stoppers / Senior Liaison, Alternative Response Coordinators, Crime Prevention Coordinator, Missing/Vulnerable Persons Coordinator, and Youth Coordinator. These positions will augment frontline service strength and enhance the capacity for proactive policing and prevention measures. CSP members will receive standard training as a team and specialized training for their designated areas

Inspector Update

Superintendent Weber introduced the Board to the 'Yellow Card' Campaign and shared a video. The goal is to eradicate the use of the offensive R-word to describe people with intellectual abilities. So far this video has received over 12,000 online hits.

Inspector Zimmerman advised that Adequacy Standards dictate that the GSPS Tactical Unit must complete a live exercise annually with various partners. An emergency exercise was conducted at the Greater Sudbury Airport in September 2015 with Airport staff, Airport Fire Staff, Emergency Management, Transport Canada, and the hospital with students from Cambrian College acting as victims. The exercise simulated a possible bomb on aircraft with low impact crash. These scenarios provide an excellent learning opportunity for all participants.

Inspector Despatie provided an update on Major Case Management. This week Skylar Dalyk was found guilty of manslaughter. Sentencing will occur at the end of November. In complex cases such as this, many units support and are involved in the investigation. The investigative teams work tireless hours in investigating the event and throughout the entire court process.

Inspector Chapman provided an update for Uniform branch. The Bear Management Committee has a number of work commitments underway including a draft Bear Management MOU. Several issues will be examined including waste management containers, practices in other jurisdictions to combat nuisance bears, and the institution of specific City bylaws. The next meeting is scheduled for October 23, 2015.

Inspector Somerset advised that recommendations for most appropriate fire dispatch resources have been updated. The solution to improve paging coverage has been agreed and currently being implemented, the CAD 9.3 software update has been instituted which will enhance officer safety.

OAPSB Conference Update

Chair Caldarelli and CAO Baiden attended the OAPSB Conference November 1-2, 2015 in Toronto. This was a good conference and had presentations on governance, labour relations trends, and contemplated changes to the *Police Services Act*. Boards will be kept updated on changes impacting on police governance as they become known. It was suggested that some of the changes could be announced as early as the spring of 2016.

Notes of Appreciation

Notes of appreciation are received by the Chief's office and reported monthly to the Board.

A letter was received from Sudbury Rainbow Crime Stoppers thanking Detective Sergeant Robert Weston for speaking to their Board on the processing of tips received. Sergeant Weston "Our Directors were very impressed with Detective Sergeant Weston's presentation and gained a better understanding of how information received and initiatives instituted directly impact the work done by law enforcement. What an excellent representative of the Service. We commend him for his dedication to making our community a safer place."

An email message was received from a Sudbury resident extending his appreciation to the uniform officers who assisted at the Labour Day celebrations at Bell Park. "I heard helpful and positive two-way conversations between officers and the public. They engaged and encouraged children, parents, and grandparents to speak and offered open arms and warm smiles. They set a good tone from arrival to departure."

Members congratulated Chief Pedersen on this achievement and honourable recognition.
