#### **IODE Youth Presentation**

Chief Pederson informed the Board that the recipient of the 2020 IODE Youth Award is Constable Stefany Mussen, who was nominated by Staff Sergeant Valerie Tiplady. Cst. Mussen holds many roles with the Service and in her personal life where she trains and mentors youth in the Greater Sudbury community. Cst. Mussen will be donating the award's \$500 prize to Big Brothers/Big Sisters of Sudbury.

Vice-Chair Caldarelli asked the Chief to pass along the Board's congratulations.

The Chief will meet privately with Cst. Mussen following this meeting to present her with this well-deserved award, which will also be documented on the Service's social media channels.

## **2020** Annual Report on Public Complaints

The Board received the 2020 Annual Report on Public Complaints. Chief Pederson noted that out of 60,000 calls for service in 2020, only 37 resulted in public complaints. This is equal to the amount of complaints in 2019. None of the Public Complaints have been substantiated or resulted in sanctions against an Officer. Two (2) are still under investigation to be completed in 2021.

## 2020 Use of Force Report

The Board received the 2020 Use of Force Report. Chief Pederson reviewed the report, stating that all Service training is in line with Ministry standards. Officers continue to follow de-escalation training.

Chief Pederson noted that Use of Force reports were up 31.7% in 2020. The primary contributing factor to the increased number of reports is that calls involving the presence of a weapon are up by 100% Chief Pederson also noted that assaults on officers during these type of Calls for Service rose in 2020.

# **Report from the Chief**

The Chief's Report was circulated to members prior to the meeting. Chief Pederson noted that there were a number of reports from the Ministry of the Solicitor-General which have been summarized for the Board's information.

## **Operational Updates**

Deputy Chief Weber noted that we continue to have large volumes of 9-1-1 calls. ECC received 21,000 calls in total in January, with 4,700 calls being for 9-1-1 Emergency Service.

The what3words app has been a great success and was used twice in January and early February to help locate citizens during Calls for Service. Of note was a Call for Service for stranded snowmobilers north of Capreol. The app has also helped the Fire Department to locate lost people more quickly.

Deputy Chief Weber also noted the Service's ongoing focus on road safety with #AnytimeAnywhere RIDE campaign.

There have been multiple high-risk arrests and vehicle takedowns. This included a joint effort with the Espanola OPP. GSPS was able to locate a vehicle fleeing a shooting in Espanola. This resulted in the arrest of three (3) suspects and recovery of a loaded gun.

Also of note was the joint investigation with Toronto Police Service that led to the arrest of two suspects and recovery of \$56,700 worth of drugs and \$500 in cash.

The Service continues to engage with public on social media with several successful public awareness campaigns.

## **New Business**

Chief Pederson indicated he would take any questions from the media after the meeting concluded.

Member Bois asked the Chief about the status of federal legislation regarding getting guns off the street. Chief Pederson replied that the legislation has only recently been provided to Police Services, so the Service is still working on reviewing and determining what the impacts on policing will be..
