## **2020 Operating Budget – 2020 to 2024 Capital Budget**

At their meeting of October 25, 2019, the Board approved the 2020 Operating Budget and 2020 to 2024 Capital Budget. This budget was subsequently presented to Council on November 19, 2019. The City Finance and Administration Committee passed the 2020 budget on December 3, 2019. This notwithstanding on December 4, 2019, the Committee revisited the police budget and have asked that the Board reduce it by \$500,000. The Board discussed this request at length and considered options to respond. After much debate, the Board authorized a reduction of \$250,000.

(2019-160) BOIS – KOKA: THAT at the request of City of Greater Sudbury's Finance and Administration Committee, the Board reconsider resolution 2019-142 in respect of the approved 2020 Operating Budget in the amount of \$62,950,756; and further

THAT the Board approves a reduction of \$250,000 in Contribution to Reserve Funds specifically for debt financing for a police facility; and further

THAT the Board approves the 2020 Operating Budget in the amended amount of \$62,700,756. and further

THAT the Board recommends that City Council accepts this budget

## **Youth Justice Program**

The Youth Justice Program is committed to providing opportunities to youth to develop skills in areas of interest. The Service will receive \$39,566 to offset student wages for the 2019/2020 year and must enter in to an Agreement in with the Ministry of Children, Community and Social Services.

(2019-161) BOIS – CALDARELLI: THAT the Greater Sudbury Police Services Board enters into an Agreement with the Ministry of Children, Community, and Social Services for the purpose of employing students in the summer Youth Justice Program for the 2019/2020 employment program.

THAT this amendment increases the fees currently charged for services by 3% effective January 1, 2020; and further

THAT that the Schedule shall be further amended to include Paid Duty rates in accordance with the Collective Agreement with the Sudbury Police Association when ratified.




