Report from the Chief

Chief Pedersen's report was circulated in advance of the meeting. The Chief reviewed his report highlighting certain activities December. Deputy Chief Cunningham reviewed the many successes and achievements of the Operational divisions. She noted Service operations at a disturbance in Coniston, an incident at 720 Bruce Street, Sudbury's participation in Project Maverick, and D/Cst. Gianfrancesco's participation in the making of a video in conjunction with Timea's Cause to combat human trafficking. D/C Cunningham also noted the 45 MCRRT and 40 EMCRRT calls; these calls help divert cases from the Emergency Department. The launch of the Festive RIDE campaign was also noted, with 252 drivers charged with impaired driving offences. As well, 200 complaints have been received for drivers not stopping for buses since September. Chair Sizer asked for a reminder of what the penalty is for not stopping for a bus. Insp. Brunette confirmed that not stopping for a bus incurs a \$500 fine and demerit points on the drivers' license.

Chief Pedersen noted the work of the Corporate Communications group, with Cst. Nickel participating in a Festive RIDE shift and the announcement of our new K9, Royal. As always, the Service takes great pride in its involvement with the community.
