

## **Who to call if you have a complaint related to Cannabis**

Odour of Cannabis inside of a building (residential or public) – City of Greater Sudbury \*311 (By-law)

Complaint of individual(s) smoking Cannabis in a Public place contrary to what is outlined in the Provincial legislation – Public Health Sudbury & Districts (*Smoke Free Ontario Act*) 705-522-9200

Complaint of individual(s) smoking Cannabis in a car or boat, call Police 705-675-9171

The following are the Federal charges and Provincial offences related to Cannabis that will be applicable starting October 17, 2018

## **Cannabis Act – Federal statute**

### **4911 - Possession of illicit or over 30g dried cannabis (or equivalent) by adult**

- 8(1)(a) - Possession of over 30g dried cannabis (or equivalent) in a public place
- 8(1)(b) - Possession of illicit cannabis

### **4912 - Possession of over 5g dried cannabis (or equivalent) by youth**

- 8(1)(c) Possession 5g of dried cannabis (or equivalent)

### **4913 - Possession of budding or flowering plants, or more than four cannabis plants**

- 8(1)(d) - Possession of one or more cannabis plants in public place (are budding or flowering)
- 8(1)(e) - Possession of more than four cannabis plants (not budding or flowering)

#### **4914 - Possession of cannabis by organization**

- 8(1)(f)- Organization possessing cannabis

#### **4921 - Distribution of illicit, over 30g dried cannabis (or equivalent), or to an organization, by adult**

- 9(1)(a)(i) - Distribute over 30g of dried cannabis (or equivalent)
- 9(1)(a)(iii) - Distribute cannabis to an organization
- 9(1)(a)(iv) - Distribute illicit cannabis

#### **4922 - Distribution of cannabis to youth, by adult**

- 9(1)(a)(ii) - Distribute cannabis to individual under 18 years of age

#### **4923 - Distribution of over 5g dried cannabis (or equivalent), or to an organization, by youth**

- 9(1)(b)(i) - Distribute over 5g of dried cannabis (or equivalent)
- 9(1)(b)(ii) - Distribute cannabis to an organization

#### **4924 - Distribution of budding or flowering plants, or more than four cannabis plants**

- 9(1)(c)(i) - Distribute one or more cannabis plants (are budding or flowering)
- 9(1)(c)(ii) - Distribute more than four cannabis plants (not budding or flowering)

**4925 - Distribution of cannabis by organization**

- 9(1)(d) - Organization distributing cannabis

**4926 - Possession of cannabis for purpose of distributing**

- 9(2) - Possession for the purpose of distributing

**4931 - Sale of cannabis to adult**

- 10(1)(a) - Sale of cannabis to an individual 18 years of age or older

**4932 - Sale of cannabis to youth**

- 10(1)(b) - Sale of cannabis to an individual under 18 years of age

**4933 - Sale of cannabis to an organization**

- 10(1)(c) - Sale of cannabis to an organization

**4934 - Possession of cannabis for purpose of selling**

- 10(2) - Possessing cannabis for the purpose of selling

**4941 - Importation and exportation of cannabis**

- 11(1) - Importing and exporting cannabis

#### **4942 - Possession of cannabis for purpose of exportation**

- 11(2) - Possession for purpose of exporting

#### **4951 - Obtain, offer to obtain, alter or offer to alter cannabis**

- 12(1)(a) - Obtain or offer to obtain cannabis by any method or process (manufacturing, synthesis, altering chemical or physical properties)
- 12(1)(b) - Alter or offer to alter the chemical or physical properties of cannabis by the use of an organic solvent

#### **4952 - Cultivate, propagate or harvest cannabis by adult**

- 12(4)(a) - Cultivate, propagate or harvest a cannabis plant that is from seed or plant material that is illicit cannabis (or offer to do so)
- 12(4)(b) - Cultivate, propagate or harvest more than four cannabis plants
- 12(5) - Cultivate, propagate or harvest more than four plants at one time in dwelling-house
- 12(6)(a) - Cultivate, propagate or harvest any cannabis plant at a place that is not their dwelling-house (or offer to do so)
- 12(6)(b) - Cultivate, propagate or harvest any living thing (other than cannabis) from which cannabis may be extracted (or to offer to do so)

#### **4953 - Cultivate, propagate or harvest cannabis by youth or organization**

- 12(7) - Young person/organization - Cultivate, propagate or harvest any living thing (other than cannabis) from which cannabis may be extracted (or to offer to do so)

**4961 - Possess, produce, sell, distribute or import anything for use in production or distribution of illicit cannabis**

- 13(1) - Possess, produce, sell, distribute or import anything with intention to use it to produce, sell or distribute illicit cannabis

**4971 - Use of young person in the commission of a cannabis offence**

- 14(1) - Use services of, or involve, a young person in commission of offence under subsection 9(1) or (2), 10(1) or (2), 11(1) or (2), 12(1), (4), (5), (6) or (7) or 13(1)

**4981 Other Cannabis Act**

- Offences under the sections in this UCR code are enforced by Health Canada Inspectors as per Stats Canada.

# **Cannabis Control Act, 2017 - Provincial**

## **8508 - Cannabis Control Act, 2017**

- 6 – Unlawful sale and distribution
- 7 – Selling or distributing to an individual under 19 years of age
- 7 (2) - Sell cannabis to person who appears to be under 25 years
- 7 (2) - Deliver purchased cannabis to person who appears to be under 25 years
- 7 (4) - Present identification not lawfully issued to holder
- 8 - Knowingly sell cannabis to intoxicated person
- 8 - Knowingly distribute cannabis to intoxicated person
- 8 - Knowingly sell cannabis to apparently intoxicated person
- 8 - Knowingly distribute cannabis to apparently intoxicated person
- 9 - Unlawful purchase of cannabis
- 10 (1) - Person under 19 years — possess cannabis
- 10 (1) - Person under 19 years — consume cannabis
- 10 (1) - Person under 19 years — attempt to purchase cannabis
- 10 (1) - Person under 19 years — purchase cannabis
- 10 (1) - Person under 19 years — distribute cannabis
- 10 (2) - Person under 19 years — cultivate cannabis
- 10 (2) - Person under 19 years — propagate cannabis
- 10 (2) - Person under 19 years — harvest cannabis
- 10 (2) - Person under 19 years — offer to cultivate cannabis
- 10 (2) - Person under 19 years — offer to propagate cannabis
- 10 (2) - Person under 19 years — offer to harvest cannabis
- 11 (1) - Consume cannabis in prohibited place other than vehicle or boat
- 12 (1) - Drive vehicle or boat with cannabis in open baggage
- 12 (1) - Have care or control of vehicle or boat with cannabis in open baggage
- 12 (1) - Drive vehicle or boat with cannabis readily available
- 12 (1) - Have care or control of vehicle or boat with cannabis readily available
- 13 – Allowing property to be used for unlawful sale or distribution
- 15 – Possessing the proceeds of an offence
- 17(2) – Remaining in a premise after being required to vacate
- 17(2) – Re-entering a premises on the same day that a person is required to vacate
